This document defines the task of creating an atmosphere of intolerance to the humiliation of women in society. This problem has been identified as one of the main directions of state policy. Gender equality, that is, equality between men and women, is one of the basic human rights. Studying articles on this topic, one can see that this factor is also the basis of a high level of economic, social and political development. According to the authors of the articles, in labor collectives in which the number of female and male employees is approximately equal, they show several times higher results than where the male sex prevails in labor collectives, especially when it comes to intellectual, not physical labor. At the same time, gender equality is an indicator of the level of democratic development of the country. To date, it should be noted that more than 1,500 women hold senior positions in the system of state and public organizations at various levels, including in ministries and departments, local executive bodies. Systematic trainings are being organized and conducted to prepare women for various leadership positions.

The balance between women and men will be ensured through the introduction of a temporary quota system in State bodies where there is gender inequality. It is planned to provide employment for needy women and low-income families, especially in rural areas, to create decent working conditions and increase the efficiency of work on their social support.
