The main goal of reforms in this sphere is to turn our country into a free civil society, a social state, where human rights and freedoms are a priority. For these purposes, a high, prosperous and happy way of life of our people, as well as the principles of equal opportunities and social protection for all segments of the population are promoted.

One of the goals of our development path, chosen from the first years of our independence, and the reforms that we are carrying out today, is undoubtedly to improve the living conditions of the citizens of our country, ensuring human integrity and dignity. Thus, it is necessary to emphasize the special attention paid to the social sphere.

The large-scale reforms that are being carried out in this area today have never been seen before in history. The work is carried out on the basis of specific programs for working with the population, comprehensive support for vulnerable groups of the population, and poverty eradication.

As a result, the amount of funds allocated from the state budget for the purpose of providing financial assistance to this category of people has been increased, and the number of recipients of social benefits this year has increased by 1.5 times compared to previous years. Currently, a transparent system for identifying families in real need among the population has been created, and their problems are studied

on the spot, even at home. Various forms and modalities of financial assistance are provided to women and children who have lost their breadwinners, and to the disabled.

One of the pressing issues today is the need to develop strict measures to ensure employment of the population. It should be noted here that in recent years our government has adopted a number of regulatory documents aimed at improving the lifestyle of the population, increasing the material, social and cultural conditions of citizens, eliminating their problems in various areas of the field.

However, there are a number of issues on our agenda that require solutions, and their solution is a task of national importance. In particular, the question of how to ensure employment for unemployed citizens in our country, why a large number of compatriots go abroad in search of work and what to do to keep them employed here remains relevant. Unemployment is a serious problem that causes dozens of problems. As a result of not engaging in socially useful work, not only this person and his family, but also the people around him can suffer economic, moral, and especially psychological damage.

Thus, practical work is carried out on the basis of such programs as "Every Family is an Entrepreneur" and "Youth is Our Future" [1.248-257], adopted on the initiative of the head of our state. Priority is given to attracting young people - the owners of the future - to entrepreneurship, revealing their entrepreneurial abilities, providing them with preferential loans to start their own business. After all, the generation that has learned entrepreneurship from a young age will be able to solve many of society's problems in the future.

Therefore, we must seriously consider the issue of training specialists who meet the demands of the modern labor market. In 2021 alone, the head of our state allocated more than one trillion dollars to train young people in professions, finance business plans, scientific ideas and discoveries created by them, as well as 100 million dollars to support young entrepreneurs.

In addition, in recent years, children from low-income families have been provided with practical assistance in terms of education and health rehabilitation. Children in need of medical care, disabled children or seriously ill children do not remain without attention from the state, girls, especially those living in remote areas and separated from their parents, are provided with certain benefits when entering higher education institutions, their profession - we can count on a number of activities, such as vocational training, preferential loans, and the allocation of subsidies.

The fate of real orphans brought up in orphanages in our country does not go unnoticed. In recent years, we have also witnessed an emphasis on creating conditions for them to find their place in the future, be useful to society, and provide them with housing. In support of our words, we can say that in 2021 alone, 50 billion soums were allocated from the state budget for these purposes, and 900 orphans were provided with housing.

Such reforms to comprehensively support the population of our country require great responsibility, determination, and perseverance from all management personnel. Based on the demands of the time, it is necessary to implement a new approach to reforms in the social sphere, a new approach to work. We can definitely say that the last two or three years have become a turning point on the path to strong social protection of our people.

We are aware that one fact that is not openly stated, but has existed for a long time, is the recognition of poverty among the population, the lack of a decent way of life for some strata, and the elimination of these shortcomings has become the main issue on the agenda. In order to find a solution to the problem, special working groups were organized in each city, district, village, microdistrict and village of the republic, families in need of assistance were identified. Work is being carried out with citizens included in the specially organized "Youth Register", "Women's Register" and "Iron Register" and practical assistance is provided. Ensuring employment for those who were included in this list was considered the only task, and in a short period of time, more than 527 thousand citizens were employed.

The problems faced by individual entrepreneurs were also eliminated, some restrictions were eliminated, and certain tax benefits for the population were introduced, resulting in a sharp increase in



the number of self-employed citizens. Thanks to the changes made to the labor legislation, the package of documents required to start working was sharply reduced, and all opportunities for entrepreneurs were opened up [2].

In order to ensure the well-being of our country, the majority of whose population lives in rural areas, improving the standard and quality of life of rural residents is an urgent task. Creating the necessary conditions for farmers and family entrepreneurs, providing them with land and material and technical resources is one of the main areas in this area.

At the moment, it can be noted that the work to provide our population with clean drinking water is carried out on a large scale, and it can be said that this year 3 trillion soums have been allocated from the state budget for this area. which is 5 times more than in 2016. means a lot. According to statistics, 73% of the population of the republic today are provided with clean drinking water [3].

In our republic, the issue of human dignity and its decent life is constantly under consideration, and the work to ensure social benefits from the state is also very important - compared to 2016, 5 times more funds have been allocated, and the population in this category is currently one million two, you can also see when it forms one hundred thousand people.

However, not all reforms implemented in this area are effective, there are many problems that need to be solved, and many shortcomings that need to be eliminated.

Therefore, it is necessary to improve the system of support for the layer in need of social protection, study what this need is and the reasons for its occurrence, look for preventive measures, provide timely assistance to such persons, this is good, it is necessary to develop a mechanism for the effective use of modern methods and technologies in work.

In this case, in our opinion, special attention should be paid to the following issues: First of all, study the regions of the population that really need social protection (especially remote and outlying areas), their living conditions, housing, drinking water, precise monitoring of the provision of medical services and other means of subsistence; Create a mechanism for providing collective and individual assistance to the population, strengthening the connection of citizens with the state, forming in them the spirit of initiative, propaganda of a high way of life; Consider the issue of including free use of urban public transport, medical and health institutions in the number of benefits provided to persons in need of state and public support; Taking into account that women living in remote villages still live in difficult conditions, develop specific measures to make their lives easier and improve their standard of living and implement them in practice; Train women in professions in accordance with the requirements of the time and create conditions for their entrepreneurial activity in a simplified manner, etc.

There are also a number of other factors that hinder the positive results of the reforms carried out in the social sphere, such as the fact that the departments associated with the industry still retain elements of old methods of work, the necessary electronic database and information are missing, or the impossibility of adequately using information technology in the work process.
