The Optional Protocol to the Convention on the Elimination of All Forms of Discrimination against Women entered into force on 22 December 2000. It consists of two procedures: the procedure for submitting to the Committee information containing complaints of an individual or a group of persons concerning the violation of the rights set forth in the Convention; is an investigative procedure under which the Committee itself may, on its own initiative, initiate an investigation into serious and systematic violations of the rights set forth in the Convention. Thus, this Optional Protocol is a procedural protocol that introduces two new procedures related to the implementation of the Convention and the violation of women's rights: the individual complaint procedure and the investigative procedure.

Violence against women is consistent with, but not limited to, the following events:

- a) physical, sexual and mental violence in the family, including beatings, sep problems, husband's abuse of wives, harm to women, operations on the female genitals, and other types of life practices 'traditional events, as well as extramarital violence and violence against women;
- (b) Physical, sexual and mental violence, including rape, sexual harassment and extortion, harassment and prostitution of women in the workplace, educational institutions, etc. trafficking and coercion into prostitution, ie offenses related to human trafficking;
- (d) Discrimination against women, whether by the State or by the incompetence of the State, regardless of where the physical, sexual or mental violence against a woman is committed, is a matter of discrimination against women (World Conference on the Status of Women, Action Plan, Article 113). A special session entitled "Women in 2000: Equality, Development and Peace between Women and Men" was held in New York on June 5-9, 2000. The session provided an opportunity for the government and civil society to share useful experiences, discuss current issues, and develop a political direction for achieving equality between men and women.
